SEQUENCE OF EVENTS

1. We began construction of our house for retirement in August 2008. I quickly became aware that the Apex Camp was using the park and canal area beyond for canoeing activities. (film footage)
2. Geographically The Sound is effectively an amphitheatre shape and as the children do not leave the Sound the resulting noise echoes around the area affecting all the residences for many hours at a time, sometimes up to 4 or 5 days a week. I personally was disturbed by the noise and felt that the levels were beyond what is normally acceptable for a quiet residential street. I started to listen around the neighbourhood to hear what other residents had to say on the matter. It soon became clear to me that there were many other residents in The Sound area who were also disturbed by the Apex Camp's noisy activities and had been "suffering in silence" for a considerable amount of time. I spoke personally to a number of residents, some elderly, who had been verbally abused by both children and Apex Group Leaders when they had complained about excessive noise. The Group Leaders are generally fairly young and fit men and women and my understanding was that when any of the residents complained directly to them, they felt somewhat intimidated by these Group Leaders.
3. I decided to take some action to consolidate the concerns of the residents who were being adversely affected and drew up a petition along with a letter outlining our concerns to the camp Manager Vince Boeske. Some 25 residences in the affected area signed the petition.
4. By the end of November I felt that the petition was ready to be handed to Mr Boeske and I planned to telephone him and make an appointment for early December to discuss the matter and hand the petition over to him.
5. On the weekend of 29 and 30 November I was in New Zealand when I received a telephone call "out of the blue" from Mark Bode of the Sunshine Coast Daily. He asked me about the petition, and advised me that he had a copy in front of him. I was startled and asked him how he knew about the petition and where he had obtained a copy. He would not answer my question. I then told him that I had not had an opportunity to meet with Mr Boeske to hand him the petition. Mark Bode then gave me a verbal undertaking not to publish anything in the newspaper until he contacted me later the following week after

my meeting with Mr Boeske. I also stated to him that if Mr Boeske and I were able to resolve the matter amicably and in a manner acceptable to both parties, then there would be no newsworthiness in the story anyway. Later on that same day, I telephoned Mark Bode to reiterate to him that I did not want him to publish anything and he once again gave me his word not to do so.

6. On Wednesday 3 December I telephoned Mr Boeske and arranged a meeting for Friday 5 December at 9.30am to present the petition. I also had a meeting with Sophie Lever, Secretary of the TWRA and I spoke at length on the phone to Warwick Daniels, Committee Member of TWRA about the matter and told them about my intended meeting with Vince Boeske (both had no objections).
7. On Friday 5 December I met with Mr Boeske at the Apex Camp and presented him with the letter and petition on behalf of the concerned residents. I also showed him some film footage of the activities and explained to him what the main problems were. Mr Boeske requested his "right hand" man join our meeting, but he was extremely aggressive towards the situation and me in general and Mr Boeske then requested him to leave the meeting (several times). For the remaining part of the meeting Mr Boeske became rather sympathetic towards the issues. He admitted that he had never been to the park to witness for himself what was happening there and recognising the seriousness of the matter, he finally agreed to work together to reach an amicable and peaceful solution.

It was suggested by Mr Boeske :-

- (a) That the canoeing groups disburse out of The Sound and in to the greater lake/canal system of Twin Waters to lessen the impact on the residents of The Sound.
- (b) Stricter supervision of the children by the Group Leaders.
- (c) To look at planning and organising a new launching area for the canoes away from the residences in The Sound, or other residential areas.

It seemed to me that it had been an amicable and fruitful meeting and he had no objection when I indicated to him my intention to relay his plans at the following weeks TWRA meeting. Towards the end of the meeting I told him about my encounter with The Sunshine Coast Daily and I

agreed with him that I would not comment to the newspaper whilst negotiations between us were progressing.

8. On Friday at approximately 1pm Mr Boeske telephoned me to let me know that he had had a meeting with the Group Leaders and that they were trying to work out a solution. (It appears that another recreational group from Mt Coolum has been using equipment from the Apex Camp and using the Sound for its activities – the permits and supervision, however, seems to be in the hands of the Apex Camp).

Mr Boeske also told me that he had had a phone call following our meeting from Mark Bode of the Sunshine coast Daily and that they had arranged a meeting for Saturday 6 December. I again told him that I did not intend to speak to the newspaper during our negotiations.

9. On Sunday 7 December the Sunshine Coast Daily printed a front page **“Wealthy Residents Want Kids Camp To Take a Hike”** and stated that residents were demanding that **“Apex Camp Mudjimba Close Its Gates”**. This is **TOTALLY** untrue.

I state that

- * I had no interview with the newspaper or any other media regarding this matter. I have not submitted anything whatsoever to the newspaper or any other media.
- * I have not discussed with Mr Boeske any other issues concerning properties close to the Apex Camp.
- * I only addressed the problems directly concerning myself and the other residents of the Sound.
- * The petition and letter, which was submitted to the Apex Camp last Friday related only to the canoeing activities in the Sound.
- * **There was absolutely never any suggestion that Apex Camp should move or “shut its gates” as was reported in the paper.**
